RESOLVED FURTHER, to furnish copy of this resolution to Land Bank of the Philippines, San Nicolas Branch and all concerned, for their information and guidance.


On motion of Member Luciano R. Caraang, duly seconded, the foregoing resolution was unanimously approved.
