**RESOLUTION NO. 2021-169**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH (DOH) REPRESENTED BY DIR. VALERIANO JESUS V. LOPEZ, MD, MPH, MHA, CESO IV, DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT I, IN HIS CAPACITY AS THE DIRECTOR OF THE REGIONAL OFFICE, IN THE IMPLEMENTATION OF THE DOCTORS TO THE BARRIOS (DTTB) PROGRAM**

**WHEREAS**, the Municipality of San Nicolas, Ilocos Norte had requested the DOH to avail the DTTB Program considering of its lack of doctors to address the health problems of the constituents, especially during these times of the COVID-19 pandemic;

**WHEREAS**, the DOH has considered Local Government Unit of San Nicolas eligible to avail the Doctors to the Barrios (DTTB) Program;

**WHEREAS**, there shall be a MOA to be entered into by and between the Municipality of San Nicolas and the DOH Regional Office in the implementation of the DTTB Program stipulating therein the responsibilities of both parties, the Provincial Health Office, DOH Central Office, the DTTB and such other conditions in the proforma MOA;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

xxx

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.*  
– xxx

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

*(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”*

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter into a Memorandum of Agreement (MOA) with the Department of Health (DOH) represented By Dir. Valeriano Jesus V. Lopez, MD, MPH, MHA, CESO IV, Department of Health-Center for Health Development I, in his Capacity as the Director of the Regional Office, in the Implementation of the Doctors to the Barrios (DTTB) Program;

**RESOLVED, FURTHER**, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Angel Miguel L. Hernando, duly seconded, foregoing resolution was unanimously approved.


