## **"RESOLUTION NO. 2022-20**

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE AMUSEMENT GAMING CORPORATION FOR THE CONSTRUCTION OF AN EVACUATION CENTER RELATIVE TO THE REQUEST FOR FINANCIAL ASSISTANCE.

**WHEREAS**, the Sangguniang Bayan has previously approved Resolution No. 2021-25 requesting the Philippine Amusement and Gaming Corporation to grant financial assistance to the Municipality of San Nicolas for the establishment of an evacuation in the locality;

WHEREAS, the availment of such grant necessitates the forging of an Agreement by and between the PAGCOR and the Local Government Unit of San Nicolas, Ilocos Norte to fully realize and attain the intendment of the construction of a Multi-Purpose evacuation center;

**WHEREAS**, the body finds the agreement to be proper and in order and therefore interposes no objection for the Local Executive to enter into;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

XXX XXX XXX

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:
- (vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter into a Memorandum of Agreement (MOA) with the Philippine Amusement Gaming Corporation for the Construction of an Evacuation Center Relative to the Request for Financial Assistance.

**RESOLVED, FURTHER,** to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
