“RESOLUTION NO. 2021-25

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE ANDREA D. DOMINGO, CHAIRMAN AND CHIEF EXECUTIVE OFFICER OF THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (P150,000,000.00) FOR THE REHABILITATION OF TRIBUTARY CANALS OF BARANGAYS 16, 17, 18, 19 AND 21 IN THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.

WHEREAS, Section 17, (Basic Services and Facilities) paragraphs a and b, section (1), sub-section (vi) of RA 7160 otherwise known as the Local Government Code of 1991 expressly provides that:

“Local Government Units shall exercise powers vested on them and discharge other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities to its constituents like the construction of infrastructure facilities such as multi-purpose hall, multipurpose pavement, plaza, sport center and other similar facilities intended primarily to service the needs of the residents of the barangay...xxx”

WHEREAS, one of the priority areas that needs to be given importance is to rehabilitate tributary canals in the municipality to provide sufficient water supply in the locality especially during the dry season. This would surely improve food production, a big help to the farmers especially during these difficult times;

WHEREAS, the desilting and rehabilitation of the waterways will also prevent erosion of the tributaries thus protecting the residents nearby from flooding during the rainy season, a vital component of the disaster risk management program of the LGU;

WHEREAS, knowing the role of PAGCOR and its many civic programs, more specifically on sport, education, livelihood, tourism, health programs and on disaster preparedness, as well as the benevolence of the Honorable Chairman and CEO, the Sangguniang Bayan deems it appropriate to seek the agency's assistance;

WHEREAS, the LGU is at the moment financially incapable of realizing such huge project thus it is constrained to seek the assistance of the Honorable Chairman and CEO of the Philippine Amusement and Gaming Corporation (PAGCOR) to extend financial assistance for the rehabilitation of the tributary canal that traverses Brgys. 16, 17, 18, 19 and 21;

NOW, THEREFORE, BE IT, AS IT IS HEREBY RESOLVED to earnestly and humbly request Hon. Andrea D. Domingo, Chairman and Chief Executive Officer, Philippine Amusement and Gaming Corporation (PAGCOR) to provide financial assistance amounting to one Hundred Fifty Million Pesos (P150,000,000.00) for the rehabilitation of canals of Barangays 16, 17, 18, 19 and 21 in the Municipality of San Nicolas, Ilocos Norte.

RESOLVED FINALLY to furnish copy of this Resolution to Hon. Andrea D. Domingo, Chairman and Chief Executive Officer, Philippine Amusement and Gaming Corporation (PAGCOR) for her favorable consideration and approval.
