“RESOLUTION NO. 2021-28

A RESOLUTION ADOPTING AND APPROVING MUNICIPAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE RESOLUTION NO. 2022-01 ENTITLED, “A RESOLUTION REPROGRAMMING THE ITEM OF THE PURCHASE OF ONE (1) UNIT GARBAGE COMPACTOR IN THE ANNUAL INVESTMENT PLAN OF 2022, TO PURCHASE OF THREE (3) UNITS RECONDITIONED GARBAGE COMPACTOR.

WHEREAS, the purchase of one (1) unit garbage compactor is included in the approved 2022 Annual Investment Plan of the Municipality which amounts to Ten Million Pesos (P10,000,000.00);

WHEREAS, the amount of Seven Million Two Hundred Thousand Pesos (P7,200,000.00) is programmed for the purchase of one (1) unit of garbage compactor in the 20% Development Plan for 2022;

WHEREAS, the available unit in the market is a brand new, push-type garbage compactor, an electronic type equipment, the spare parts of which is still limited in the local market;

WHEREAS, in consideration of the high maintenance of a brand new push-type garbage compactor, and the scarcity of mechanical parts, the Body deems it wiser to purchase three (3) units reconditioned dump-type Garbage Compactor Trucks in lieu of a brand new one;

WHEREAS, the maintenance and repair of reconditioned dump-type Garbage Trucks would be less expensive than that of a new one and thus would be more advantageous to the municipality;

WHEREAS, after a thorough study of the Committee on Finance, Budget and Appropriations and the Committee on Laws, Rules, Ethics, Privileges and Good Government, it was found out that the same is in order;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION, to adopt and approve Municipal Development Council Executive Committee Resolution No. 2022-01 entitled, “A Resolution Reprogramming the Item of the Purchase of One (1) Unit Garbage Compactor in the Annual Investment Plan of 2022, to
