### **“MUNICIPAL ORDINANCE NO. 2022-08**

**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2022-04 ENTITLED, “AN ORDINANCE ALLOWING THE EXTENSION OF THE TIME OF PAYMENT OF APPLICABLE TAXES, FEES AND CHARGES FOR A SINGLE UNIT TRICYCLE AS DEFINED AND PROVIDED UNDER MUNICIPAL ORDINANCE NO. 2008-22 AND MUNICIPAL ORDINANCE NO. 2017-18 RELATIVE TO THE MOTORIZED TRICYCLE OPERATOR’S PERMIT FROM JANUARY 21, 2022 TO FEBRUARY 28, 2022 WITHOUT SURCHARGES OR PENALTIES”.**

**BE IT ENACTED** by the Sangguniang Bayan of San Nicolas, Ilocos Norte in session duly assembled, that:

**SECTION 1.** Title, Section 1 and Section 2 of Municipal Ordinance No. 2022-04 provides, that:

“AN ORDINANCE ALLOWING THE EXTENSION OF THE TIME OF PAYMENT OF APPLICABLE TAXES, FEES AND CHARGES FOR A SINGLE UNIT TRICYCLE AS DEFINED AND PROVIDED UNDER MUNICIPAL ORDINANCE NO. 2008-22 AND MUNICIPAL ORDINANCE NO. 2017-18 RELATIVE TO THE MOTORIZED TRICYCLE OPERATOR’S PERMIT FROM JANUARY 21, 2022 TO FEBRUARY 28, 2022 WITHOUT SURCHARGES OR PENALTIES”

**SECTION 2.** The Title, is hereby amended as follows:

“AN ORDINANCE ALLOWING THE EXTENSION OF THE TIME OF PAYMENT OF BUSINESS TAXES, FEES AND CHARGES FROM **JANUARY 21, 2022 TO MARCH 11, 2022** WITHOUT SURCHARGES OR PENALTIES”

**SECTION 3.** Section 1 and Section 2, is hereby amended as follows:

“SECTION 1. *Title.* - This ordinance shall be known as an “Ordinance Allowing the Extension of the Time of Payments of Applicable Taxes, Fees, and Charges for Single Unit Tricycle as defined and provided under Municipal Ordinance No. 2017-18 and Municipal Ordinance No. 2008 relative to the Motorized Tricycle Operator’s Permit from **January 21, 2022 to March 11, 2022** without surcharges or penalties”.

SECTION 2. *Extension.* - The time of payments of applicable taxes, fees and charges is hereby extended from **January 21, 2022 to March 11, 2022** without surcharges or penalties.”

**SECTION 4. *Separability Clause.*** If for any reason, any section, provision or item of this Ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions hereof.

**SECTION 5. *Effectivity.*** This ordinance shall take effect upon approval.






