**“MUNICIPAL ORDINANCE NO. 2022-09”**

**AN ORDINANCE GRANTING A FIFTEEN PERCENT (15%) DISCOUNT IN THE RENTAL FEES IMPOSED BY THE LOCAL GOVERNMENT UNIT TO LESSEES OF STALLS, BOOTHS, KIOSKS AND SPACES AT THE SAN NICOLAS PUBLIC MARKET FOR THE PERIOD OF MARCH 1, 2022 TO JUNE 30, 2022.**

**WHEREAS**, the COVID-19 pandemic still pervades and the lessees of stalls, booths, kiosks and spaces at the San Nicolas Public Market continue to bear the hardships of coping up with the adverse effects of the virus;

**WHEREAS**, the Local Government Units (LGU) is finding ways to ease the burden of these small and micro business establishments to help them recover and deal with the ill economic effects of this dreaded epidemic;

**WHEREAS**, Municipal Ordinance No. 2021-20 known as *The grant of 15% discount on rental fees at the San Nicolas Public Market* is only effective until December 31, 2021;

**WHEREAS**, the proprietors who availed of the 15% discount are still experiencing a decrease in their sales due to the pandemic resulting to low income at the Public Market;

**WHEREAS**, it is the Sangguniang Bayan which is clothed with authority to grant discount on the rental fees imposed by the LGU to operators of businesses, at the Public Market, thus it was

**RESOLVED AND ORDAINED, THAT:**

**SECTION 1. Short Title.** This ordinance shall be known as the grant of 15% discount on rental fees at the San Nicolas Public Market.

**SECTION 2. Purpose.** Consistent with the LGU’s policy of providing means to alleviate the hardships of the populace in the municipality specially the market vendors, there shall be a relief to the payment of rental fees by providing a discount.

**SECTION 3. Authority.** The Sangguniang Bayan is authorized by law to grant reliefs and discounts to the imposed obligations to business operators in the municipality, pursuant to RA 7160.

**SECTION 4. Grant of 15% Discount.** A fifteen percent (15%) discount is hereby granted to all rental fees imposed upon by the LGU to lessees of stalls, kiosks, booths and spaces at the San Nicolas Public Market on the condition that the said lessees have valid and subsisting Business Permit.

**SECTION 5.** The stalls occupied by the Cooperative Rural Bank of Cabugao and the Cooperative Rural Bank of Ilocos Norte are not covered by this ordinance.

**SECTION 6. Effectivity.** This Ordinance shall commence and takes effect on March 1, 2022 until June 30, 2022.
