"RESOLUTION NO. 2022-59

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPAL HEALTH OFFICE SAN NICOLAS AND THE MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER FOR THE UTILIZATION OF TANGGUYOB REFERRAL SYSTEM FOR DISASTER PREPAREDNESS AND RESPONSE TO REDUCE THE EFFECTS OF EXTREME EMERGENCIES AND DISASTER.

WHEREAS, the Mariano Marcos Memorial Hospital and Medical Center, being a tertiary level teaching and training DOH-Retained Hospital, is capable of specialized and sub-specialized forms of treatment and management, surgical procedures, and intensive care, equipped with state-of-the-art machineries and equipment, to cater referred patients, and is capable for disaster preparedness and management and building community resilience;

WHEREAS, the Municipal Health Office San Nicolas, is a health facility that provides essential health care;

WHEREAS, the Mariano Marcos Memorial Hospital and Medical Center, as part of its Service Delivery Network covering the provinces of Ilocos Norte provides a network in the provision of care to referred emergency cases, timely and safe conduct of transfer and provision of subspecialty care for high risk neonates thru the Newborn Emergency Transport Service (NETS), and disaster management;

WHEREAS, the Municipal Health Office San Nicolas, after initial and thorough examination of patients, determines that the case needs further management from tertiary lelvel care with the help of trained medical practitioners requiring adept, but not limited to, medical, surgical, obstetric, NETS, and intensive management;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:



Page 2, Resolution No. 2022-59;

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) between the Municipal Health Office San Nicolas and the Mariano Marcos Memorial Hospital and Medical Center for the utilization of TANGGUYOB Referral System for Disaster Preparedness and Response to reduce the effects of extreme emergencies and disaster.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
