A RESOLUTION SUPPORTING AND CONCURRING THE PROGRESSIVE EXPANSION OF LIMITED FACE TO FACE LEARNING MODALITY OF ALL PUBLIC AND PRIVATE SCHOOLS WITHIN THE MUNICIPALITY.

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases issued a resolution placing Ilocos Norte under Alert level 1 status;

WHEREAS, areas under Alert Level 1 status are allowed to conduct face to face classes provided that there is an approval from the Office of the President;

WHERAS, one of the requirements to be eligible to participate in the implementation of limited face to face learning modality is the passage of a Resolution from the Sangguniang Bayan allowing the conduct of face-to-face classes;

WHEREAS, the challenges brought by remote learning has come to the attention of the Local Government Unit specially for elementary school students as they need a certain level of guidance, social interaction, and tactile learning opportunities that are difficult to replicate in an online classroom.

Online classes also come with financial burden due to the required device to be used and payment for a more stable connection for an uninterrupted learning session.

Parents/ guardians, especially those who are working were greatly affected as well. They couldn't help but to sacrifice some of their time to act as a substitute teacher to properly guide and teach their child on certain topics that online classes simply couldn't accommodate. All of these in order to properly give the educational attention that a young learner needed.

WHEREFORE, given the continuous improvement of the Covid 19 situation in our municipality be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan Assembled in Session to support and concur with the progressive expansion of limited face-to-face modality of both public and private schools within the municipality.

RESOLVED FURTHER to transcribe copies of this resolution and furnish same to all concerned schools and offices for their information, reference and appropriate action.
