“MUNICIPAL ORDINANCE NO. 2022-13

AN ORDINANCE AUTHORIZING A TEMPORARY INCREASE OF THE FARE RATE OF TRICYCLES OPERATING AND PLYING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE

WHEREAS, the Sangguniang Bayan received a petition from the Presidents of San Nicolas Damili Tricycle Operators and Drivers Association requesting for an increase of tricycle fare due to the sudden and massive increase in price of oil products;

WHEREAS, while the Sangguniang Bayan sympathizes on the welfare of the riding public, the current tricycle fare is obviously not sufficient to sustain the needs of the tricycle drivers and operators;

WHEREAS, the Municipality of San Nicolas, finds it imperative to increase provisionally the fare of tricycle-for-hire to allow the One Thousand Six Hundred Fifty (1,650) tricycle operators/drivers to mitigate the negative effect brought by the abrupt increase in the prices of gasoline;

WHEREAS, this measure is enacted after a consultation and public hearing conducted by the Sangguniang Bayan and in consideration with the price increase in gasoline of tricycle-for-hire, number of passengers, and distance of travel.

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of San Nicolas, Ilocos Norte, in session duly assembled, that:

SECTION 1. Title. - This Ordinance shall be known as an “Provisional Fare Rate of tricycles operating and plying within the municipality”

SECTION 2. Fare at Poblacion. - The regular fare rate within the poblacion is as follows:

- a. P20.00 for 1 passenger
- b. P15.00 each for 2 to 4 passengers

SECTION 3. Regular fare rates from poblacion to rural barangays and vise-versa and such other destinations are indicated in the Annex A attached hereto and which forms an integral part of this ordinance.

SECTION 4. *Discount for students, senior citizens, and persons with disability.*

A 20% discount on fare rates of senior citizens and persons with disability is hereby authorized pursuant to existing laws.

A 20% discount on fare rates of students is also hereby granted and authorized.

SECTION 5. *Penal Provision.* – Any person who violates this Ordinance shall be penalized as follows:

- a. First Offense - A fine in the amount of Five Hundred Pesos (P500.00);
- b. Second Offense - A fine in the amount of One Thousand Pesos (P1,000.00);
- c. Third Offense - Revocation of tricycle franchise.

If the offender is the tricycle driver who is not the operator, the latter should be held solidarily liable with the former.

SECTION 6. *Repealing Clause.* - All ordinances, rules and regulations, or parts thereof, in conflict with, or inconsistent with any provisions of this Ordinance, are hereby repealed, amended, or modified accordingly.

SECTION 7. *Separability Clause.* - If for any reason or reasons, a part or provision of this ordinance is declared contrary to law, morals, public order or public policy, all other provisions shall remain valid and effective.


SECTION 8. *Effectivity Clause.* - This Ordinance shall take effect immediately upon approval for a duration of two (2) months.


