“RESOLUTION NO. 2022-77

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. ALFREDO P. VALDEZ, JR., M.D. TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN NICOLAS, ILOCOS NORTE, A MEMORANDUM OF AGREEMENT WITH THE OFFICE OF THE PRESIDENT REPRESENTED BY THE EXECUTIVE SECRETARY SALVADOR C. MEDIALDEA REGARDING THE GRANT AMOUNTING TO TEN MILLION PESOS (P10,000,000.00) AS ASSISTANCE CHARGED TO SOCIO-CIVIC PROJECTS FUND (SCPF).

WHEREAS, President Rodrigo Roa Duterte sees the need to provide financial assistance to the LGU-San Nicolas affected by the health crisis brought about by the Corona Virus Disease (COVID-19);

WHEREAS, the assistance shall be used to cater and address the immediate needs of the people affected by the COVID-19 within the areas of LGU-San Nicolas;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.

– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Municipal Mayor, Hon. Alfredo P. Valdez, Jr., M.D. to enter into and sign, for and in behalf of the Municipal Government of San Nicolas, Ilocos Norte, a Memorandum of Agreement with the Office of the President Represented by the Executive Secretary Salvador C. Medialdea regarding the grant amounting to Ten Million Pesos (P10,000,000.00) as assistance charged to Socio-Civic Projects Fund (SCPF).

RESOLVED, FURTHER, to transcribe copies of this resolution to the Office of the President represented by the Executive Secretary Salvador C. Medialdea and all concerned, for their information and appropriate action;

On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.
