“RESOLUTION NO. 2022-80

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS STATE UNIVERSITY (MMSU) REGARDING THE ESTABLISHMENT OF A SOCIAL LABORATORY OF THE MUNICIPALITY’S ACTIVITIES, TEACHING-LEARNING PROCESS FOR FACULTY AND STUDENTS AND THE RESEARCH AND EXTENSION FOR DEVELOPMENT.

WHEREAS, the Mariano Marcos State University (MMSU) and the Municipal Government of San Nicolas agree to cooperate on specialized grassroots sustainable development collaborative partnerships based on the principles of, responsiveness, resiliency, reciprocity, and symbiosis;

WHEREAS, it encourages the exchange of knowledge resource and facilities between local government officials and personnel and the university faculty members, researchers and extension workers including their respective clientele and partners in academic research and extension for development, business and community engagement, and sustainable development will be enhanced and will be increased by the establishment of such exchanges.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.

– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) With The Mariano Marcos State University (MMSU) regarding the establishment of a social laboratory of the municipality’s activities, teaching-learning process for faculty and students and the research and extension for development.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.
