- 6) Barangay Appropriation Ordinance No. 2022-01 of Barangay 16, San Marcos entitled, "An Ordinance Authorizing the Annual Budget of Barangay 16, San Marcos, San Nicolas, Ilocos Norte for Calendar Year 2022 in the Total Amount of Five Million Four Hundred Eighteen Thousand Two Hundred Ten Pesos (P5,418,210.00) Covering the Various Expenditures for the Operation of the Barangay Government of Barangay 16, San Marcos, San Nicolas, Ilocos Norte for the Period January 1 to December 31, 2022 and for other purposes";
- 7) Barangay Appropriation Ordinance No. 2022-01 of Barangay 21, San Agustin entitled, "An Ordinance Authorizing the Annual Budget of Barangay 21, San Agustin, San Nicolas, Ilocos Norte for Calendar Year 2022 in the Total Amount of Four Million Eight Hundred Forty Four Thousand Two Hundred Fifty Three Pesos (P4,844,253.00) Covering the Various Expenditures for the Operation of the Barangay Government of Barangay 16, San Marcos, San Nicolas, Ilocos Norte for the Period January 1 to December 31, 2022 and for other purposes".






