“RESOLUTION NO. 2022-91

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY AND THE SAN NICOLAS SUGARCANE PRODUCERS ASSOCIATION IN CONNECTION WITH THE PROVISION OF THREE (3) UNITS SUGARCANE JUICER.

WHEREAS, the “LGU-San Nicolas” is primarily tasked, by virtue and existing laws of the land, to assist and/or support various qualified farmer organizations and cooperatives in establishing various projects and programs geared towards agricultural development;

WHEREAS, the “LGU-San Nicolas” spearheads the provision of agricultural projects particularly farm machineries and equipment and post-harvest facilities to the different farmers association and cooperative of the municipality;

WHEREAS, the San Nicolas Sugarcane Producers Association is of good standing and duly registered Farmer’s Association under the Securities and Exchange Commission (SEC) and accredited as Rural Based Organization (RBO) by the LGU-San Nicolas;

WHEREAS, the San Nicolas Sugarcane Producers Association has been yearning to have Sugarcane Juicer to be used in sugarcane processing;

WHEREAS, the “LGU-San Nicolas” shall grant the “San Nicolas Sugarcane Producers Association” three (3) units Sugarcane Juicer for them to use in barangay and adjacent barangays;

WHEREAS, the Sugarcane Juicer will address the problem of sugarcane processing in the barangay and the locality as well;

WHEREAS, the “San Nicolas Sugarcane Producers Association” shall operate and maintain the production facility (Sugarcane Juicer) at their own expense to efficiently improve processing activities;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Page 2, Resolution No. 2022-91;

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby RESOLVED by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) between the municipality and the San Nicolas Sugarcane Producers Association in connection with the provision of Three (3) Units Sugarcane Juicer.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.
