“RESOLUTION NO. 2022-99

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE RURAL HEALTH UNIT OF SAN NICOLAS AND THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT – I REGARDING THE GRANT OF ONE COVID-19 ALLOWANCE (OCA) FOR PUBLIC AND PRIVATE HEALTH WORKERS AND NON-HEALTH CARE WORKERS IN THE MUNICIPALITY.

WHEREAS, Republic Act (RA) No. 11639, or the General Appropriations Act (GAA) for Fiscal Year (FY) 2022, provides the basis for fund release on the grant of COVID-19 benefits for public and private health workers and non-health care workers and non-health care workers, regardless of employment status, who are involved in COVID-19 response in all health facilities including military hospitals, Government-Owned and Controlled Corporations (GOCCs), state university hospitals and private-licensed health facilities;

WHEREAS, FY 2022 GAA Special Provision, specifically Section 14, allocates 2022-001 dated January 14, 2022, or the Guidelines for COVID-19 Risk Exposure Classification of Health Care Workers, was issued to set the parameters for determining the risk exposure of personnel in COVID-19 response-involved health facilities;

WHEREAS, the Department of Budget and Management (DBM) and DOH issued Joint Circular (JC) No. 2022-0001, dated February 10, 2022, providing the guidelines for the grant of One COVID-19 Allowance (OCA) for public and private health care workers and non-health care workers.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the Municipality and Sign the Memorandum of Agreement (MOA) between the Rural Health Unit of San Nicolas and the Department of Health Center for Health Development – I regarding the Grant of One COVID-19 Allowance (OCA) for Public and Private Health Workers and Non-Health Care Workers in the municipality.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.
