**A RESOLUTION EXPRESSING THE SINCEREST SYMPATHY AND HEARTFELT
CONDOLENCES OF THE PEOPLE OF SAN NICOLAS TO THE BEREAVED FAMILY OF THE
LATE HONORABLE DOMINGO “DOMING” CURIMAO AMBROCIO, JR., MUNICIPAL MAYOR
OF SAN NICOLAS, ILOCOS NORTE.**

WHEREAS, this Necrological Service is rendered to give due respect, honor and to pay our last homage to a dedicated public servant in the person of **Honorable Mayor Domingo C. Ambrocio, Jr.** of Brgy. 10, San Paulo, San Nicolas, Ilocos Norte;

WHEREAS, the untimely death of **Mayor Domingo Ambrocio, Jr.** brought a pall of gloom and utter disbelief to the entire town and its people, most especially to his family, relatives, friends and countless supporters, who were witness to his colorful career as public servant;

WHEREAS, he started his political career as Chairman of the Sangguniang Kabataan and Brgy. Kagawad in his barangay, dealing with his barangaymates with much devotion to his duties, endearing him to many, who until today profess their admiration and support to him;

WHEREAS, in 2001, he was elected as member of the Sangguniang Bayan riding on his closeness to the masses, literally surviving the onslaught of political big rigs in the town, who had lorded it over in the august halls of the Sanggunian. He was then reelected twice in 2004 and 2007 placing first in both elections;

WHEREAS, the unprecedented rise of his political career did not change his demeanor and closeness to the poor and enjoyed mingling with his constituents, remained as a low profiled official, a gentleman whom every San Nicoleño can easily reach out; And in 2010, he ran and won a seat at the Provincial Board, and there he exchanged and argued ideas against seasoned politicians. With his wit and eloquence, he was always championing still, the welfare of the common people; In 2013, he returned to his homebase winning again a seat in the Municipal Council and consequently was elected as PCL Chairman in the province qualifying him a seat in the Sangguniang Panlalawigan as an Ex-Officio member;

WHEREAS, his stint at the Provincial Board enabled him to deal with high officials of the Province, and with his dedication to his oath and duties as a public servant, he earned and won the respect of his colleagues, notably the Marcos Family. And in 2022, he ran and won convincingly as Municipal Mayor of his dear town of San Nicolas, the ultimate prize he had dreamed of, in his colorful journey;

WHEREAS, “**Doming**” as known to many, is a loving husband and family man, a friend unparalleled, always finding time, enjoying light moments with them, providing the laughter, the affection and love a truly good man could afford; He is now leaving us all, his loving wife, his dear town, his relatives and countless friends to meet his Creator, with fervent prayers that his soul may finally rest in peace;

NOW, THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Bayan in session to express the sincerest sympathy and heartfelt condolences of the people of San Nicolas, Ilocos Norte to the bereaved family.
