“RESOLUTION NO. 2022-186

A RESOLUTION ADOPTING AND APPROVING THE ABANDONMENT OF THE CONTINUING APPROPRIATION FROM THE SAVINGS OF DRRM FUND FOR THE PURCHASE AND ACQUISITION OF PORTABLE TOILETS, RESCUE BOAT, GPS DEVICE AND SIREN AMOUNTING TO THREE HUNDRED FOURTEEN THOUSAND AND ONE HUNDRED TWENTY PESOS (P314,120.00), AND REAPPROPRIATING THE SAME FOR THE PROPOSED PROGRAMS AND ACTIVITIES UNDER THE MDRRMC FOR CY 2022 AS EMBODIED IN THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 2022-01.

WHEREAS, there is a Continuing Appropriation from the savings of DRRM Fund allocation for the purchase and acquisition of portable toilets, rescue boat, GPS device and siren amounting to Three Hundred Fourteen and One Hundred Twenty Pesos (P314,120.00);

WHEREAS, the MDDRRMC deems it necessary that the above stated amount be reverted to the General Fund and be utilized for the following programs and activities:

1) Conduct of drills and Simulation Exercise	P54,000.00
2) Provision of IEC materials	55,000.00
3) Provision of emergency assistance	100,000.00
4) Conduct of DRR-related contests	75,120.00
5) Conduct of blood donation	30,000.00
TOTAL	P314,120.00

WHEREAS, the Committee on Finance recommended that the MDDRRMC resolution be adopted for the abandonment of the projects and authorizes its reappropriation for identified PPA’s necessary to carry out the programs of the DRRMMO;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to approve the abandonment of the continuing appropriation from the savings of DRRM Fund for the purchase and acquisition of portable toilets, rescue boat, GPS device and siren amounting to Three Hundred Fourteen Thousand and One Hundred Twenty Pesos (P314,120.00), and reappropriating the same for the proposed programs and activities under the MDRRMC for CY 2022 as embodied in the Municipal Disaster Risk Reduction and Management Council (MDRRMC) Resolution No. 2022-01.

RESOLVED FURTHER to transcribe copies of this resolution and furnish same to all concerned, for their information and guidance.
