“RESOLUTION NO. 2022-190

A RESOLUTION ADOPTING AND APPROVING THE ABANDONMENT OF THE CONTINUING APPROPRIATION OF THE PROJECT SEWAGE MANAGEMENT AND REHABILITATION OF CANAL AMOUNTING TO ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00) AND EIGHT HUNDRED THOUSAND PESOS (P800,000.00) RESPECTIVELY UNDER THE OPERATIONS OF THE MARKET AND REAPPROPRIATING THE SAME FOR THE IMPROVEMENT/REHABILITATION OF THE PUBLIC MARKET.

WHEREAS, there is a Continuing Appropriation of the Project Sewage Management and Rehabilitation of Canal Amounting to One Million Four Hundred Thousand Pesos (P1,400,000.00) and Eight Hundred Thousand Pesos (P800,000.00) respectively under the Operations of the Market;

WHEREAS, the Municipal Mayor deems it necessary that the above stated amount be reverted to the General Fund and be utilized for the Improvement/Rehabilitation of the Public Market;

WHEREAS, the Committee on Finance recommended that a resolution be adopted for the abandonment of the projects and authorizes its reappropriation for the improvement/rehabilitation of the public market;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to adopt and approve the Abandonment of the Continuing Appropriation of the Project Sewage Management and Rehabilitation of Canal Amounting To One Million Four Hundred Thousand Pesos (P1,400,000.00) and Eight Hundred Thousand Pesos (P800,000.00) respectively under the Operations of the Market and Reappropriating the same for the improvement/rehabilitation of the Public Market.

RESOLVED FURTHER to transcribe copies of this resolution and furnish same to all concerned, for their information and guidance.


On motion of Member Norberto S. Dadiz, Jr., duly seconded, foregoing resolution was unanimously approved.
