WHEREAS, the municipality is expecting the amount of One Hundred Forty Million Four Hundred Eight Thousand Three Hundred Ninety Pesos (P140,408,390.00) as its Internal Revenue Allotment (IRA) share for the year 2023;

WHEREAS, 20% of the total IRA amounting to Twenty Eight Million Eighty One Thousand Six Hundred Seventy Eight Pesos (P28,081,678.00) is set aside as the Development Fund of the municipality;
