“RESOLUTION NO. 2022-199

A RESOLUTION EARNESTLY REQUESTING THE CONGRESS OF THE PHILIPPINES THRU THE HONORABLE EUGENIO ANGELO MARCOS BARBA, REPRESENTATIVE OF THE SECOND DISTRICT OF ILOCOS NORTE/CHAIRMAN, COMMITTEE ON NORTH LUZON GROWTH QUADRANGLE TO CONSIDER THE PASSAGE OF THE APPROPRIATE LAW, RECLASSIFYING THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FROM SECOND CLASS TO A FIRST CLASS MUNICIPALITY.

WHEREAS, in 2004, the Municipality of San Nicolas was classified as a fourth class municipality and was reclassified as a third class town in 2005;

WHEREAS, from then on, investments came in pouring in the locality which resulted in the increase of local revenues and the municipality was further reclassified as a second class town in 2007;

WHEREAS, the reclassification of municipalities was then vested in the Department of Finance, which promptly makes the adjustments in compliance to the guidelines and regulations in the classifications of Local Government Units;

WHEREAS, the Municipality of San Nicolas is still at present classified as a second class municipality but now technically a first class town considering its vast income coming from the continuing increase of revenues;

WHEREAS, the reclassification of towns apparently took a standstill which in effect deprived LGUs from enjoying the benefits and stature of being a municipality of a higher class;

WHEREAS, efforts were made by the LGU as to how reclassification is undertaken and found out that such discretion was divested from the Department of Finance and now lies in the Congress of the Republic;

WHEREFORE, be it **RESOLVED** as it is hereby **RESOLVED BY THE** Sangguniang Bayan to earnestly request the Congress of the Philippines thru the Honorable Eugenio Angelo Marcos Barba, Representative of the Second District of Ilocos Norte/Chairman, Committee on North Luzon Growth Quadrangle to pass/enact the appropriate law reclassifying the municipality of San Nicolas from a second class town to a first class municipality.
