A RESOLUTION EARNESTLY REQUESTING THE HONORABLE POLICE GENERAL RODOLFO AZURIN, JR., CHIEF OF THE PHILLIPPINE NATIONAL POLICE (PNP) FOR THE PROVISION OF A PATROL CAR IN THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.

WHEREAS, one of the key programs of the Local Government Unit of San Nicolas, Ilocos Norte, is the maintenance of peace and order, as well as the protection and preservation of life, limb, and properties of its constituents;

WHEREAS, the municipality is rapidly becoming the business hub not only in the province but in the entire region, where big business establishments such as the Robinsons Ilocos Mall, Save More Supermart, Call Centers, restaurants, prime car dealers and resort hotels are now located;

WHEREAS, to date the municipality has one run down patrol and one donated by the LGU which may not be proportionate to the huge number of people coming to the municipality on a daily basis;

WHEREAS, there is a need to acquire additional patrol car order for the municipality to efficiently suppress criminality and effectively maintain peace and order in the town;
