WHEREAS, there is an available amount of Thirty Million Four Hundred Nine Thousand Two Hundred Fourteen Pesos and Fifty Centavos (P30,409,214.50) from the RA 7171 Tobacco Excise Tax FY 2019 Collection (LBM 84);

WHEREAS, several programs and projects were identified/prioritized to be funded from the above-mentioned share of the municipality from the RA 7171;

WHEREAS, these programs and projects were already incorporated in the 2022 Annual Investment Program except for some projects as mentioned in the Supplemental Annual Investment Program;

WHEREAS, after careful review and deliberation on the proposed programs and projects, the body approved the Supplemental Annual Investment Program for CY 2022;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION, to adopt and approve the Supplemental Annual Investment Program of the Municipality of San Nicolas, Province of Ilocos Norte for the Year 2022 as embodied in the Municipal Development Council Resolution No. 2022-03, copy of the same is hereto attached;
