WHEREAS, Sections 34 and 35 of RA 7160 otherwise known as the Local Government Code of 1991 provide and call for the meaningful participation of qualified organizations and associations in the pursuit of local autonomy and furtherance of development, and institutionalize their participation through the local special bodies;

WHEREAS, the ZANJERA San Marcos Small Water Impounding System Irrigators Association, Inc. has participated and got involved with the different programs and projects of the municipality;

WHEREAS, the ZANJERA San Marcos Small Water Impounding System Irrigators Association, Inc. is a centuries-old trade of the San Nicolas which has been a source of livelihood and now part of its heritage.

WHEREAS, after a thorough scrutiny on the background of the organization, the August Body, through the Committee on Agriculture and Cooperatives has found out that the ZANJERA San Marcos Small Water Impounding System Irrigators Association, Inc. has met all the requirements for reaccreditation;
