“RESOLUTION NO. 2022-240

A RESOLUTION DESIGNATING THE HONORABLE LUCIANO R. CARAANG, HONORABLE MOERA JOY N. GALING-LUNA, AND HONORABLE CHONA P. HERNANDEZ AS MEMBERS OF THE REGULATORY REFORM TEAM FOR THE CONDUCT OF REGULATORY REFORM ACTIVITIES PURSUANT TO THE EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICES ACT OF 2019 DESIGNATING ITS COMPOSITION, RULES AND RESPONSIBILITIES AND FOR OTHER PURPOSES.

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2022-075 dated June 6, 2022 regarding the Guidelines on the Implementation of Regulatory Reform for LGUs Information System (RR4LGUsIS);

WHEREAS, pursuant to Section 5 of Republic Act No. 11032, Ease of Doing Business and Efficient Government Service Delivery (EODB-EGSD) Act of 2018, “All offices and agencies which may provide government services are hereby mandated to regularly undertake cost compliance analysis, time and motion studies, undergo evaluation and improvement of their transaction systems and procedures and reengineer the same if deemed necessary to reduce bureaucratic red tape and processing time”;

WHEREAS, the Department of the Interior and Local Government (DILG) in collaboration with the Anti-Red Tape Authority (ARTA) issued Joint Memorandum Circular No. 2019-01 entitled: “Guidelines on the Regulatory Reform for LGUs pursuant to the Ease of Doing Business and Efficient Government Service Delivery (EODB-EGSD) Act of 2018” on December 10, 2019 requires that the Sangguniang Bayan Members who will be designated as members of the RRT must be made through a Sangguniang Bayan Resolution.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to Designate the Honorable Luciano R. Caraang, Honorable Moera Joy N. Galing-Luna, and Honorable Chona P. Hernandez as Members of the Regulatory Reform Team for the Conduct of Regulatory Reform Activities Pursuant to the Ease of Doing Business and Efficient Government Services Act of 2019 Designating its Composition, Rules and Responsibilities and for other purposes.
