“RESOLUTION NO. 2022-243

A RESOLUTION EARNESTLY REQUESTING THE HON. ANGELO MARCOS BARBA, REPRESENTATIVE OF THE SECOND DISTRICT OF THE PROVINCE OF ILOCOS NORTE TO PROVIDE FUNDS FOR THE CONSTRUCTION AND REHABILITATION OF A DIKE ALONG PADSAN RIVER FOR THE PROTECTION OF NEARBY RESIDENTS ESPECIALLY AT BRGYS. 6 AND 24, SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the Laoag River Basin Flood Control and Sabo Project was constructed in response to periodic flooding problems compounded by excessive sediment deposition over the river flood plain and alluvial fans;

WHEREAS, the operation and maintenance of the project is expected to create a more pleasant and safe living environment for residents in the flood prone areas in the Basin, protect farm lands and promote agricultural activities, and spur growth and development in the province;

WHEREAS, due to heavy rains, typhoons, and floods, residents of the municipality have complained for that they have feared about their safety and security. Moreso there is a large deposit of flood water in those areas that could not be released into the water outlets and sluice gates;

WHEREAS, there is a need therefore to cause the necessary undertakings in the municipality in order that lives and properties would not be at stake;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to earnestly request the Hon. Angelo Marcos Barba, Representative of the Second District of the Province of Ilocos Norte to Provide Funds for the Construction and Rehabilitation of a Dike Along Padsan River for the Protection of Nearby Residents Especially at Brgys. 6 and 24, San Nicolas, Ilocos Norte.

RESOLVED, FURTHER, to furnish copy of this Resolution to the Hon. Angelo Marcos Barba, Representative of the Second District of the Province of Ilocos Norte for his utmost consideration and information.
