“RESOLUTION NO. 2022-267

WHEREAS, Sections 34 and 35 of RA 7160 otherwise known as the Local Government Code of 1991 provide and call for the meaningful participation of qualified organizations and associations in the pursuit of local autonomy and furtherance of development, and institutionalize their participation through the local special bodies;

WHEREAS, the Association of Senior Citizen in San Nicolas, Ilocos Norte, Inc. has participated and got involved with the different programs and projects of the municipality;

WHEREAS, the Association of Senior Citizen in San Nicolas, Ilocos Norte, Inc. is a centuries-old trade of the San Nicolas which has been a source of livelihood and now part of its heritage.


On motion of Member Erico R. Ruiz, Jr., duly seconded, the foregoing resolution was unanimously approved.
