“MUNICIPAL ORDINANCE NO. 2022-24

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF LEAÑO AVENUE (FROM THE MADAMBA ST. TO THE CORNER OF GEN. LUNA ST.) WEST OF THE SAN NICOLAS MUNICIPAL HALL BUILDING AND THE OLD PLAZA, THE ROAD SHOULDERS SOUTH OF SAN NICOLAS ELEMENTARY SCHOOL TO BE USED FOR THE SAN NICOLAS FOOD FAIR AND TRADE EXHIBITS AND SALE OF MERCHANDISES AGRICULTURAL PRODUCTS DURING THE DURATION OF NOVEMBER 12 UNTIL DECEMBER 31, 2021.

WHEREAS, the Local Government Unit of San Nicolas thru the Damili Festival Executive Committee has come up with various programs and activities to make the celebration more worthwhile to the townspeople;

WHEREAS, the cravings for variety of street and locally made foods is part and parcel of the festivities and a more spacious area is needed to accommodate vendors and retailers;

WHEREAS, a portion of Leaño Road and the road shoulders of Madamba St. were identified as possible areas;

NOW, THEREFORE, BE IT ENACTED by the Sangguniang of the Municipality of San Nicolas, Province of Ilocos Norte assembled in session, that:

SECTION 1. Authority. The Sangguniang Bayan is authorized by law specifically the Local Government Code of 1991 to enact measures relative to the use and closure of roads within its territorial jurisdiction.

SECTION 2. Coverage. A portion of Leaño Avenue shall be closed from November 12 until December 31, 2022, to be used as the venue for the San Nicolas Holiday Food Fair, trade fair exhibits and related activities as part of the celebration of the Damili Festival 202.

Likewise, the shoulders of Madamba St. south of the San Nicolas Elementary School shall also be closed to be used as selling area of assorted goods and merchandise during the same period of November 12 until December 31, 2022.


SECTION 3. This ordinance shall take effect on the specified dates in the preceding sections of this ordinance.
