**A RESOLUTION EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF ILOCOS NORTE (PGIN), THRU THE HONORABLE GOVERNOR MATTHEW JOSEPH MARCOS MANOTOC, TO PROVIDE FINANCIAL ASSISTANCE TO THE MUNICIPALITY OF SAN NICOLAS IN THE AMOUNT OF EIGHT MILLION PESOS (P8,000,000.00), FOR THE IMPROVEMENT OF THE SAN NICOLAS PUBLIC MARKET (FARMERS TRADING CENTER).**

**WHEREAS**, the San Nicolas Public Market remains the center of trade and business for the Small and Medium entrepreneurs in the municipality as well as nearby places, especially the farmers who by themselves bring their farm produce in the marketplace;

**WHEREAS**, the Local Government Unit (LGU) has started the rehabilitation of the market utilizing available but meager funds to improve and provide a more conducive place for businesses to thrive;

**WHEREAS**, the municipality has devised a plan to accommodate more vendors and consumers especially during the open market days thru the construction of a spacious shed at the southern portion of the area;

**WHEREAS**, the Sangguniang Bayan deems it appropriate to seek assistance from concerned national agencies including the PGIN to realize the proposed project and program;

**WHEREAS**, the PGIN has been a dependable partner of every LGU in the province and continues to in its program of providing assistance for community development geared towards the upliftment of the quality of living of every citizen;

**NOW, THEREFORE**, be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session to earnestly request the Provincial Government of Ilocos Norte (PGIN), thru the Honorable Governor Matthew Joseph Marcos Manotoc, to provide Financial Assistance to the Municipality of San Nicolas in the Amount of Eight Million Pesos (P8,000,000.00), for the Improvement of the San Nicolas Public Market (Farmers Trading Center).


On motion of Member Moera Joy N. Galing-Luna., duly seconded, foregoing resolution was unanimously approved.
