“RESOLUTION NO. 2022-280-A

A RESOLUTION EARNESTLY REQUESTING THE ROBINSONS MALL, INC. THRU THE MALL MANAGER, TO FINANCIALLY ASSIST THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE FOR THE REHABILITATION/REPAIR/IMPROVEMENT OF THE DAYCARE CENTERS AT BARANGAYS 5, 18, 19 AND 20.

WHEREAS, COVID-19 has practically disrupted the normal operation of all kinds of businesses causing enormous economic reverses, halting the conduct of face to face classes in all school levels including those in Early Childhood Development program (Daycare);

WHEREAS, the non-usage of school buildings and facilities, poor maintenance and the factor of wear and tear, brought reparations to these institutional structures making them inconvenient and worse pose danger to all learners and teachers as well;

WHEREAS, considering the opening up of face-to-face classes, there is a compelling need to repair and rehabilitate these buildings to accommodate the returning students;

WHEREAS, the Municipal Social Welfare and Development Officer (MSWDO) and the Municipal Engineer after conducting inspection of all school edifices in the municipality, recommended that the Day Care Centers of Barangays 5, 18, 19 and 20 need to rehabilitated and repaired;

WHEREAS, the LGU of San Nicolas at present has no available funds to utilize for these projects, thus the Sangguniang Bayan deems it wise to seek assistance from partners in development such as the Robinsons Mall which had previously aiding the municipality in various programs congruent to their Corporate Social Responsibility (CSR) program;

NOW, THEREFORE, be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan duly assembled, to earnestly request the Robinsons Mall, Inc. Thru the Mall Manager, to Financially Assist the Municipality of San Nicolas, Ilocos Norte for the Rehabilitation/Repair/Improvement of the Daycare Centers at Barangays 5, 18, 19 and 20.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Erico R. Ruiz, Jr., duly seconded, foregoing resolution was unanimously approved.
