**“RESOLUTION NO. 2022-281**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY AND THE MARIANO MARCOS STATE UNIVERSITY FOR THEIR STUDENTS TO UNDERGO PRACTICUM/INTEGRATED LEARNING (HR 198) IN REPUTABLE ORGANIZATIONS TO OBSERVE AND ACQUIRE HANDS-ON EXPERIENCE ON THE DIFFERENT AREAS OF HRM.**

**WHEREAS**, student trainees shall be in good health for the duration of the practicum work;

**WHEREAS**, student trainees shall be personally held accountable and liable for damages to and/or loses of equipment and supplies due to their willful act, omission or negligence;

**WHEREAS**, student trainees shall renounce and waive any claim against MMSU and the LGU for any injury or pecuniary loss that they may suffer arising from their willful acts, omission and negligence in the performance of their duties and functions while under training;;

**WHEREAS**, student trainees undergo pre-practicum seminar, briefing and orientation on work values, behavior and discipline to ensure smooth cooperation with the LGU;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.*  
– xxx

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

*(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”*

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) between the Municipality and the Mariano Marcos State University for their Students to Undergo Practicum/Integrated Learning (HR 198) in Reputable Organizations to Observe and Acquire Hands-On Experience on the Different Areas of HRM.

**RESOLVED, FURTHER**, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
