“RESOLUTION NO. 2022-285

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MUNICIPALITY AND THE SCHOOLS DIVISION OF ILOCOS NORTE FOR THE IMPLEMENTATION OF THE “READ AND LEAD: DEVELOPING A COMMUNITY OF READERS AND OTHER RELATED FUNCTIONAL LITERACY PROGRAMS” A LITERACY AND CONTINUING EDUCATION PROGRAM BETWEEN THE MUNICIPAL GOVERNMENT OF SAN NICOLAS, ILOCOS NORTE AND THE SCHOOLS DIVISION OF ILOCOS NORTE.

WHEREAS, the MOU is necessary and vital to address the concerns on literacy and education particularly in the aspect of improving the reading level of learners;

WHEREAS, supporting the call of President Ferdinand R. Marcos, Jr. during his public statement at the New York Stock Exchange Economic Forum held on September 20, 2022 where he vowed to improve the Philippines’ education system by providing learners with the skill training they need and stressed the need to focus more on honing students’ skills to make them ready as they enter the workforce;

WHEREAS, desiring to address concerns and issues on reading, communication, and other related functional literacy programs, there is a need to establish a stronger partnership between the Municipal Government of San Nicolas, Ilocos Norte and the Schools Division of Ilocos Norte;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the Municipality and sign the Memorandum of Understanding (MOU) between the municipality and the Schools Division of Ilocos Norte for the implementation of the “Read and Lead: Developing a Community of Readers and other related functional literacy programs” a Literacy and Continuing Education Program between the Municipal Government of San Nicolas, Ilocos Norte and the Schools Division of Ilocos Norte.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Luciano R. Caraang, duly seconded, foregoing resolution was unanimously approved.
