“RESOLUTION NO. 2022-291

A RESOLUTION ADOPTING AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FOR THE YEAR 2022 AS EMBODIED IN THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2022-04.

WHEREAS, there is an available amount of Thirty Million Four Hundred Nine Thousand Two Hundred Fourteen Pesos and Fifty Centavos (P30,409,214.50) as the first release and Four Million Four Hundred Ninety Two Thousand Seven Hundred Sixteen Pesos (P4,492,716.00) as the second release of the remaining 50% of RA 7171 as per LBM 83 and LBM 84 with the total of Thirty Four Million Nine Hundred One Thousand Nine Hundred Thirty Pesos and 50/100 (P34,901,930.50);

WHEREAS, in August 26, 2022 the Executive Committee of the Local Development Council passed a Supplemental Annual Investment Program for the programs and projects which were not included in the Annual Investment Program of 2022;

WHEREAS, the provision of assistance to association in the Approved 2022 Annual Investment Program is only Two Million Pesos (P2,000,000.00) which is not sufficient, hence the need for Supplemental Annual Investment Program;

WHEREAS, after careful review and deliberation on the proposed programs and projects, the body approved the Supplemental Annual Investment Program for CY 2022;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION, to adopt and approve the Supplemental Annual Investment Program of the Municipality of San Nicolas, Province of Ilocos Norte for the Year 2022 as embodied in the Municipal Development Council Resolution No. 2022-04, copy of the same is hereto attached;

WHEREFORE, on motion of Member Erico R. Ruiz, Jr., duly seconded, the foregoing resolution was unanimously approved.

RESOLVED FURTHER to transcribe copies of this resolution and furnish the same to the Local Chief Executive and to all concerned, for their reference and guidance.


