A RESOLUTION GIVING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A CONTRACT WITH A QUALIFIED SPORTS OFFICIATING SERVICE PROVIDER FOR THE CONDUCT OF THE INTER-BARANGAY AND INTER-AGENCY BASKETBALL TOURNAMENT OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the inclusion of the inter-barangay and inter-agency basketball tournament in the town's festivities has long been a tradition;

WHEREAS, in order that the conduct of the said tournament will be smooth and orderly, competent and expert referees be hired to man every game;

WHEREAS, a Qualified Sports Officiating Service Provider is willing to provide their services subject to the terms and conditions as embodied in the Contract;

WHEREAS, the Municipal Government in its efforts to guide the youth in their endeavors aimed to uplift the welfare of the youth sector shall abide to the terms and conditions set forth in the Contract;

NOW, THEREFORE, be it resolved by the Sangguniang Bayan in session to authorize the Local Chief Executive to enter into a Contract with a Qualified Sports Officiating Service for the conduct of the inter-barangay and inter-agency basketball tournament of the Municipality of San Nicolas, Ilocos Norte;

RESOLVED FURTHER to transcribe copy of this resolution and furnish same to the Local Chief Executive for his information and appropriate action.


On motion of Member Inno Ma. Angelo Paulo O. Hernando, duly seconded, the foregoing resolution was unanimously approved.
