**“RESOLUTION NO. 2022-298**

**A RESOLUTION AUTHORIZING THE USE OF A PORTION OF LOT NO. 10685-B OF THE SAN NICOLAS CADASTRE, REGISTERED UNDER THE NAME OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE AS SITE FOR THE ESTABLISHMENT AND CONSTRUCTION OF AN EVACUATION CENTER.**

**WHEREAS**, one of the five (5) pillars and core thrusts of the Local Government Unit of San Nicolas is an efficient Disaster Risk Reduction and Management program primarily aimed to mitigate the effects of natural and man-made calamities,

**WHEREAS**, the Sangguniang Bayan has previously requested funding support from concerned national agencies for the construction and establishment of an evacuation center, spacious enough to accommodate displaced victims of calamities;

**WHEREAS**, the area to be established needs to be proximate to the majority of the inhabitants, so as to make the relief and rescue operations of the MDRRMC much easier;

**WHEREAS**, there is an available lot registered and owned by the Municipality of San Nicolas, located at Brgy. 22, San Guillermo particularly described as Lot No. 10685-B CAD 307-D which can accommodate the area needed in the construction of the proposed evacuation center;

**WHEREAS**, the LGU is willing to allow the use of a portion of the said lot and thus the Sangguniang Bayan hereby assembled in session, authorizes as it hereby authorizes the use of a portion of the above described lot for the construction and establishment of an evacuation area.


On motion of Member Jorge Cesar T. Palafox, duly seconded, the foregoing resolution was unanimously approved.
