“RESOLUTION NO. 2022-301

A RESOLUTION AUTHORIZING THE DISTRIBUTION OF THE LUMP SUM APPROPRIATION UNDER THE OFFICE OF THE MAYOR IN THE SUPPLEMENTAL BUDGET FOR FY 2022 FOR PERFORMANCE BASED-BONUS TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES IN THE DIFFERENT OFFICES OF THE MUNICIPALITY, AMOUNTING TO TWO MILLION FORTY-FOUR THOUSAND NINE HUNDRED FIFTY-FIVE & 40/100 (PHP2,044,955.40).

WHEREAS, the grant of Performance-Based Bonus is a simplified scheme adopted to strengthen the effectiveness of the existing incentive system and assist agencies and instrumentalities in achieving the goals and expected outputs of the government;

WHEREAS, the Municipality of San Nicolas, Province of Ilocos Norte was listed as eligible by the Department of the Interior and Local Government, having complied with the criteria and guidelines set forth by concerned authorities;

WHEREAS, the Sangguniang Bayan enacted Municipal Ordinance No. 2022-authorizing Supplemental Budget No. 2, which provides among others the allocation of Performance-Based Bonus to qualified municipal officials and employees;

WHEREAS, the amount of Php2,044,955.40 granting PBB was a lump sum appropriation under the Office of the Mayor, thus an authorization from the Sangguniang Bayan is imperative for it to be distributed to the qualified grantees;

WHEREFORE, be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to Authorize the Distribution of the Lump Sum Appropriation under the Office of the Mayor in the Supplemental Budget for FY 2022 for Performance Based-Bonus to Qualified Municipal Officials and Employees in the Different Offices of the municipality, amounting to Two Million Forty-Four Thousand Nine Hundred Fifty-Five & 40/100 (Php2,044,955.40).

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Erico R. Ruiz, Jr., duly seconded, foregoing resolution was unanimously approved.
