“MUNICIPAL ORDINANCE NO. 2022-25

AN ORDINANCE PROHIBITING THE SETTING UP OF RETAIL SPACE FOR THE SELLING OF GOODS, FOODS OR MERCHANDISE WITHIN AND AROUND THE VICINITY OF F.E.M. MINI CULTURAL SPORTS CENTER.

WHEREAS, in previous years, it has been a practice to set up stalls beside the mini cultural center which was then allowed by the municipality in order to encourage the establishment of small businesses and support to livelihood of local community. However, with the increase of vehicles passing through the roads beside the F.E.M. Mini Cultural Sports Center, it has become a nuisance and became dangerous to the passing vehicle and the customers of these stalls.

WHEREAS, it was also observed that stalls set up within the mini cultural center creates unnecessary crowd along the entrance which obstructs the ingress to and egress from the mini cultural sports center.

WHEREAS, in order to maintain the orderliness and cleanliness around and within the vicinity it is thus necessary to prohibit the setting up of stalls within and around the vicinity of mini cultural sports center in order to ensure a smooth flow of traffic and provide safe and convenient movement of persons.

WHEREAS, the Sanggunian Bayan shall regulate the use of streets, avenues, alleys, sidewalks, bridges parks, and prohibit the putting of encroachments or obstacles there, and when necessary, in the interest of public welfare authorize the removal of encroachments and illegal construction in public places pursuant to Article III, Sec.447 Paragraphs 5 (v), (vi) of the Local Government Code.

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of San Nicolas, Ilocos Norte, in session duly assembled, that:

SECTION 1. Prohibited Act. No person shall set up retail stalls for the selling of goods, foods or merchandise within and around the vicinity of F.E.M. Mini Cultural Sports Center.

SECTION 2. Purposes. This Ordinance has the following purposes:

- a. To maintain cleanliness and orderliness in the F.E.M. Mini Cultural Sports Center;
- b. To improve the flow of traffic around the vicinity of F.E.M. Mini Cultural Sports Center
- c. To maintain the smooth movement of person entering into and going out of the Mini Cultural Sports Center.
- d. To get rid of illegal vendors on streets.

SECTION 3. Penalty. Violation of this Ordinance shall be punished by a fine of One Thousand Pesos (P1,000.00).

SECTION 4. Repealing Clause. - All ordinances, rules and regulations, or parts thereof, in conflict with, or inconsistent with any provisions of this Ordinance, are hereby repealed, amended, or modified accordingly.

SECTION 5. Separability Clause. - If for any reason or reasons, a part or provision of this ordinance is declared contrary to law, morals, public order or public policy, all other provisions shall remain valid and effective.


SECTION 6. Effectivity Clause. - This Ordinance shall take effect immediately upon approval.
