## **"RESOLUTION NO. 2022-340**

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY, PRESIDENT FERDINAND "BONGBONG" R. MARCOS, THRU THE NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES (NHCP) TO APPROVE OR CAUSE APPROPRIATE ACTION FOR DECLARING THE 26<sup>TH</sup> OF DECEMBER ONWARDS AS OFFICIAL MUNICIPAL HOLIDAY OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE IN THE OBSERVANCE AND CELEBRATION OF THE DAMILI FESTIVAL.

**WHEREAS**, RA 7160, otherwise known as the Local Government Code of 1991 mandates Local Government Units to ensure, support and enrich their culture within their respective jurisdictions;

**WHEREAS**, the Municipality of San Nicolas, Province of Ilocos Norte takes pride of its rich cultural heritage and traditions, making its preservation as municipal policy and part of its agenda for development;

**WHEREAS**, in pursuit of this mandate, the municipality through the Sangguniang Bayan, enacted Municipal Ordinance No. 2009-12, naming the Annual Town's Festivities as DAMILI FESTIVAL where the centuries old pottery industry of the town is showcased and is celebrated on December 26-30 of every year;

**WHEREAS**, it must also be stressed that "placing culture at the heart of development policy constitutes an essential investment in the world's future and pre-condition to successful globalization processes that take into account the principles of cultural diversity (<a href="https://www.unesco.org">www.unesco.org</a>);

**WHEREAS**, the LGU of San Nicolas had been persistent and consistent with its cultural preservation program, even earning the prestigious 2018 "Galing Pook Award" in line with this program;

**WHEREAS**, towards this end, the municipality has to preserve the irreplaceable historical and cultural foundation of this historic town as a living part of community life and development to further sustain and enrich the sense of pride, identity and the way of life of every San Nicoleño:

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to Earnestly Request his Excellency, President "Bongbong" R. Marcos, thru the National Historical Commission of the Philippines (NHCP) to Approve or Cause Appropriate Action for Declaring the 26<sup>th</sup> of December Onwards as Official Municipal Holiday of the Municipality of San Nicolas, Province of Ilocos Norte in the Observance and Celebration of the Damili Festival.
