“RESOLUTION NO. 2022-347

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF UNDERSTANDING BETWEEN THE PHILIPPINE DRUG ENFORCEMENT AGENCY – REGION I FOR THE IMPLEMENTATION OF THE BALAY SILANGAN PROGRAM.

WHEREAS, Dangerous Drug Board (DDB) Regulation No. 2, series of 2018 sets forth the guidelines for the reformation of drug personalities who voluntarily surrendered to authorities but are not drug users and the provision of livelihood training, after-care and community/social re-integration programs through cooperation with the LGUs, the National Government and other stakeholders.

WHEREAS, the municipality through its MADAC and BADAC shall provide updates of the validated list of illegal drug personalities at the barangay level;

WHEREAS, the municipality through its MHO, shall provide the necessary skills and expertise to ensure the health and well-being of the program beneficiaries who wish to undergo the reformation program under the BALAY SILANGAN;

WHEREAS, the PDEA shall provide assistance in the screening of surrenders and shall spearhead efforts in the conduct of advocacy activities with regard the implementation of the BALAY SILANGAN program;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Represent the Municipality and Sign the Memorandum of Understanding Between the Philippine Drug Enforcement Agency – Region I for the Implementation of the Balay Silangan Program.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Inno Ma. Angelo Paulo O. Hernando, duly seconded, foregoing resolution was unanimously approved.
