**“MUNICIPAL ORDINANCE NO. 2023-01**

**AN ORDINANCE FURTHER AMENDING SECTION 2 OF MUNICIPAL ORDINANCE NO. 2022-18 ENTITLED, “AN ORDINANCE AMENDING SECTION 8 OF MUNICIPAL ORDINANCE NO. 2022-13 OTHERWISE KNOWN AS, “AN ORDINANCE AUTHORIZING A TEMPORARY INCREASE OF THE FARE RATE OF TRICYCLES OPERATING AND PLYING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE”.**

**BE IT ENACTED** by the Sangguniang Bayan of San Nicolas, Ilocos Norte in session duly assembled, that:

**SECTION 1.** Section 2 of Municipal Ordinance No. 2022-18 provides, that:

**“SECTION 8. Effectivity Clause - This Ordinance shall take effect immediately upon approval until December 31, 2022.”**

**SECTION 2.** Section 2 of Municipal Ordinance No. 2022-18 is hereby amended as follows:

**“SECTION 2. Section 8, is hereby amended as follows:**

**SECTION 8. Effectivity Clause - This Ordinance shall take effect immediately upon approval until March 31, 2023.”**

**SECTION 3. Effectivity.** This ordinance shall take effect upon approval.

**UNANIMOUSLY APPROVED.”**


