WHEREAS, the Municipality of San Nicolas, is a bustling commercial and business center in the Province of Ilocos Norte, considering its proximity to the City of Laoag, the City of Batac and the populous and booming towns of Dingras, Sarrat and Paoay;

WHEREAS, the populace of the County of Maui, Hawaii, USA, consists considerably numerous Asians, a large number of it are Filipinos mostly coming from the Province of Ilocos Norte;
