“MUNICIPAL ORDINANCE NO. 2023-08

AN ORDINANCE FURTHER EXTENDING THE TIME OF PAYMENT OF BUSINESS TAXES, FEES AND CHARGES FOR THOSE WHO HAVE UPLOADED THEIR DOCUMENTS ON OR BEFORE 11:59 O'CLOCK P.M. OF FEBRUARY 17, 2023 WITHOUT SURCHARGES OR PENALTIES UNTIL 5:00 O'CLOCK PM OF FEBRUARY 20, 2023.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION DULY ASSEMBLED THAT:

SECTION 1. *Title.* - This ordinance shall be known as an “Ordinance Further Extending the Time of Payment of Business Taxes, Fees and Charges.”

SECTION 2. *Applicability.* – This ordinance is only applicable to those who have uploaded the required documents in their business permit applications on or before 11:59 o'clock P.M. of February 17, 2023. Applicants who failed to upload the required documents by the stipulated date and time will no longer be qualified.

SECTION 3. *Uploading of Documents.* – To accommodate applicants who were able to upload the needed requirements on or before 11:59 o'clock P.M. of February 17, 2023, it is but just and equitable under the circumstances, that they will be allowed to pay whatever assessment be made by the concerned Officer at the Office of the Municipal Treasurer so as not to be meted surcharges.

SECTION 4. Extension of the time of payment. - The time of payments of business taxes, fees and charges is hereby extended from February 17, 2023 to February 20, 2023 until 5:00 o'clock in the afternoon for those who have uploaded their documents on time, without the imposition of surcharges, interest or other penalties.

SECTION 3. Separability Clause. If for any reason or reasons, a part or provision of this ordinance is declared contrary to law, morals, public order or public policy, all other provisions shall remain valid and effective.


SECTION 4. Effectivity. This ordinance shall take effect upon approval.


