“MUNICIPAL ORDINANCE NO. 2023-10

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF LEAÑO AVENUE (FROM THE MADAMBA ST. TO THE CORNER OF GEN. LUNA ST.) WEST OF THE SAN NICOLAS MUNICIPAL HALL BUILDING AND THE OLD PLAZA FOR THE SAN NICOLAS FOOD FAIR AND TRADE EXHIBITS AND SALE OF MERCHANDISES DURING THE DURATION OF APRIL 3, 2023 TO APRIL 9, 2023.

WHEREAS, the Municipality of San Nicolas joins the nation in the commemorating the Lenten season culminated by the observance of the Holy Week;

WHEREAS, tourists from various places seek solemnity and refuge in the Province of Ilocos Norte to relive the tradition of visiting Old and Heraldic Churches and at the same time find rest in famous beaches and notable tourist spots in the locality:

WHEREAS, the LGU of San Nicolas deems it wise to put up food caravans as well as a trade exhibit where local merchandise and products would be offered for sale during the duration of the Holy Week;

WHEREAS, a portion of Leaño Avenue west of the Municipal Hall Building and fronting the Balay San Nicolas, was identified as a suitable area;

NOW, THEREFORE, BE IT ENACTED by the Sangguniang of the Municipality of San Nicolas, Province of Ilocos Norte assembled in session, that:

SECTION 1. Authority. The Sangguniang Bayan is authorized by law specifically the Local Government Code of 1991 to enact measures relative to the use and closure of roads within its territorial jurisdiction.

SECTION 2. Coverage. A portion of Leaño Avenue shall be closed from April 3, 2023 to April 9, 2023, to be used as the venue for the San Nicolas Holiday Food Fair, trade fair exhibits and related activities in observance of the Holy Week.


SECTION 3. This ordinance shall take effect immediately upon approval.
