**“RESOLUTION NO. 2023-115**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY AND THE MARIANO MARCOS STATE UNIVERSITY REGARDING THE REVIVED DAMILI EXTENSION PROJECT.**

**WHEREAS**, MMSU-College of Business, Economics and Accountancy (CBEA) Extension Unit through the Community and Enterprise Development Program (CEDP) and the Marketing Link Project of the BSBA Marketing Management (BSBA MM) Program are identified to help enhance the marketing skills and knowledge of “damili” industry along social media marketing (SMM);

**WHEREAS**, MMSU trains the pottery producers as the end-beneficiaries of the extension program;

**WHEREAS**, LGU San Nicolas helps in the implementation and monitoring of the extension program that will further improve and preserve the “damili” culture of its constituents;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

xxx

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.*

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) between the municipality and the Mariano Marcos State University Regarding the Revived Damili Extension Project.

**RESOLVED, FURTHER**, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
