**“RESOLUTION NO. 2023-121**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) AMONG THE MUNICIPALITY, THE PHILIPPINE STATISTICS AUTHORITY (PSA) AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE COMMUNITY-BASED MONITORING SYSTEM.**

**WHEREAS**, the Community-Based Monitoring System (CBMS) is an organized technology-based system of collecting, processing, and validating necessary disaggregated data that may be used for planning, program implementation, and impact monitoring at the local level while empowering communities to participate in the process;

**WHEREAS**, the PSA shall be the lead agency in the implementation of the CBMS pursuant to Republic Act (RA) No. 11315 also known as the CBMS Act;

**WHEREAS**, Rule VI, Section 7 of the Implementing Rules and Regulations of the CBMS Act tasked the DILG to develop and implement information and education campaign relating to CBMS; ensure compliance of the LGUs in the various CBMS activities; and extend assistance to PSA in the conduct and implementation of the CBMS;

**WHEREAS**, Section 4 of the CBMS provides that the LGU is the primary data collecting authority within its locality;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.*  
– xxx

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

*(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”*

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) among the municipality, the Philippine Statistics Authority (PSA) and the Department of the Interior and Local Government (DILG) for the Community-Based Monitoring System.

**RESOLVED, FURTHER**, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Luciano R. Caraang, duly seconded, foregoing resolution was unanimously approved.


