“RESOLUTION NO. 2023-123

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY AND THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT – I (DOH CHD-I) FOR THE GRANT OF HEALTH EMERGENCY ALLOWANCE (HEA).

WHEREAS, the Department of Health Center for Health Development – I (DOH CHD-I) and the LGU San Nicolas, Ilocos Norte entered in a Memorandum of Agreement for the grant of HEA to the eligible health care workers pursuant to Republic Act No. 11712 known as the Public Health Emergency Benefits and Allowances for Health Care Workers Act and its Implementing Rules and Regulations;

WHEREAS, Section I. D of the said MOAA provides that transferred funds must be utilized for its intended purpose within one (1) month from the transfer of funds but not later than December 31, 2023;

WHEREAS, Section II of the said MOA provides that Agreement shall be effective from the date of its execution unless shortened by these circumstances: a) mutually agreed in writing by the parties; b) termination for justifiable cause after due notice; c) exhaustion of transferred funds; d) insufficiency or unavailability of funds; e) the Agreement purposes or reasons have been accomplished or failed to exist, respectively or f) until December 31, 2023;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) between the municipality and the Department of Health Center for Health Development – I (DOH CHD-I) for the Grant of Health Emergency Allowance (HEA).

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.


