"RESOLUTION NO. 2023-128

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY AND THE MARIANO MARCOS STATE UNIVERSITY REGARDING THE IMPLEMENTATION OF THE SCHOOL-ON-THE-AIR (SOA) PROGRAM ON GOAT AND SWINE PRODUCTION IN ILOCOS NORTE.

WHEREAS, MMSU through its Extension Directorate endeavors to disseminate and promote the utilization of developmental information and technologies among the public through deliberate, effective and efficient ways in partnership with other development agencies, local government units, and people's organizations to achieve its mission and vision by way of conducting the MMU Rimat ti Ilocandia: School-on-the-Air (SOA) Program/Eskwela iti Tangatang;

WHEREAS, the LGU cooperates and coordinates with other agencies of government and private institutions to carry-out a more effective and efficient delivery of development services to its area of jurisdiction and to the people herein;

WHEREAS, the emergence of various infectious diseases that affected the livestock and poultry industry provided a great loss in the income of community members:

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. - (a) Every local government unit, as a corporation, shall have the following powers:

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) between the municipality and the Mariano Marcos State University regarding the implementation of the School-on-the-Air (SOA) Program on Goat and Swine Production in Ilocos Norte.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
