WHEREAS, the Municipal Health Office has been vastly improved in terms of facility and laboratory equipment as well as birthing services which are all now in place;

WHEREAS, the Department of Health (DOH) has prescribed guidelines and standards for a Health Office to be classified and upgraded into a Primary Health Care Facility, which include extended services especially emergency cases;

WHEREAS, the improvement of delivery of health services had been a battle cry of the present administration and have adopted and implemented measures in responding to emergency cases and catering to them during nighttime;

WHEREAS, the upgrading of the Municipal Health Office into a Primary Health Care Facility is a welcome development as its maintenance and improvement would be supported by the DOH and that it would cater more patients;
