## A RESOLUTION ADOPTING AND APPROVING THE CONTINGENCY PLAN FOR TROPICAL CYCLONES OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE AS EMBODIED IN THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL RESOLUTION NO. 2022-08.

**WHEREAS**, Republic Act 10121 states that it shall be the policy of the State, among others, "to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities, strengthening the country's institutional capacity for disaster risk reduction and management and building the resilience of local communities;

WHEREAS, Section 12 (c) of said Act mandates the provincial/city/municipal, barangay DRRMOs to facilitate and support risk assessment and contingency planning activities at the local level;

**WHEREAS**, Section 2 (g) of said Act emphasized the need to mainstream disaster risk reduction and climate change in development processes;

**WHEREAS**, after careful review and deliberation on the proposed programs and projects, the body approved the MDRRMC Resolution No. 2022-08;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION, to adopt and approve the Contingency Plan for Tropical Cyclones of the Municipality of San Nicolas, Ilocos Norte as Embodied in the Municipal Disaster Risk Reduction and Management Council Resolution No. 2022-08, copy of the same is hereto attached;
