“RESOLUTION NO. 2022-361

A RESOLUTION ADOPTING AND APPROVING THE PUBLIC SERVICE CONTINUITY PLAN FOR CY 2023 OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE AS EMBODIED IN THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL RESOLUTION NO. 2022-10.

WHEREAS, the National Disaster Risk Reduction and Management Council (NDRRMC) issued NDRRMC Memorandum Circular No. 33, Series of 2018 mandating all government agencies to prepare a Public Service Continuity Plan (PSCP);

WHEREAS, the Civil Service Commission through Memorandum Circular No. 2, Series of 2021 also mandates all government units to formulate PSCPs;

WHEREAS, the Public Service Continuity Plan is an all-hazard plan that aims to ensure continuous delivery of services to the public amidst any disruption by assessing the internal capacities, identify recovery requirements and strategies to minimize damage and loss to essential processes, ensure succession of leadership and improve continuity of all government entities;

WHEREAS, after careful review and deliberation on the proposed programs and projects, the body approved the MDRRMC Resolution No. 2022-10;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION, to adopt and approve Public Service Continuity Plan for CY 2023 of the Municipality of San Nicolas, Ilocos Norte as embodied in the Municipal Disaster Risk Reduction and Management Council Resolution No. 2022-10, copy of the same is hereto attached;
