**A RESOLUTION ADOPTING AND APPROVING THE PREPAREDNESS MEASURES TO BE UNDERTAKEN IN THE OBSERVANCE OF THE 2023 LENTEN SEASON AND SUMMER VACATION IN THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE AS EMBODIED IN MDRRMC RESOLUTION NO. 2023-02.**

**WHEREAS**, the Lenten Season or Semana Santa is a significant annual religious observance for the Filipino Roman Catholic which begins on Palm Sunday and continues on through Eastern Sunday;

**WHEREAS**, during this season, majority of Filipinos join the rush to go home to their respective hometowns and provinces to spend this holy festivity together with their families which also signals the start of the summer vacation;

**WHEREAS**, this is also the time when devotees go to churches to attend mass to reflect and offer prayers and tourists flock to churches and identified tourism establishments which amplifies the vulnerability of these people to human-induced hazards;

**WHEREAS**, the possibility of the occurrence of natural hazards cannot be ruled out during this time;

**WHEREAS**, after careful review and deliberation on the proposed programs and projects, the body approved the MDRRMC Resolution No. 2023-02;
